Chair's Report

Overview

This year has been a challenging but successful time for the Society, which continues to grow in strength to support its members in accordance with its Charter. The challenging aspect has manifest itself with much turbulence within the Board, both Officers and Trustees - indeed, a fundamental lack of sufficient trustees at one point - and the cessation of the Help Line, due to insufficient volunteers to man it effectively. Success has been evident starting with the Annual excellent Conference and Medical Presentations, in Birmingham, the first ever Behcet's Conference held in Northern Ireland (Belfast), a popular Family Weekend in Cumbria, initiatives within the research particularly community, and the documentation of a Behçet's Drug Pathway, and the continued developments within the three Behçet's Patient Centres. This has all been underpinned by record membership figures and much fundraising activities by members and friends which is highly commendable.

Annual Conference

The Annual General Meeting and Conference took place at The Plough and Harrow, Birmingham, on 15 October, attended by 73 people. The first part of the day was taken up with the business of the society, followed by Medical presentations. These covered an Overview of Behçet's Disease (BD) and therapies, Current research in BD, Psychological factors in living with BD, BD in children and update on Behçet's Patient Support, and findings from the health-related quality of life (HRQoL) survey.

The 17th International Conference on Behçet's Disease –incl Patients Conference 2016

Members of the Behçet's Medical Panel and Behçet's Forum attended this important bi-Annual conference in Matera, Italy, and a full report was produced in Newsletter No 39 (Spring 2017). The Society funded a bursary so that Peter and Louise May could attend the International Patients Conference, as part of the above, who reported back fully in Newsletter No 38. They were the sole UK patient representatives, amongst a myriad of patient representatives from other countries.

The Behçet's Forum Meeting

The Behçet's Forum met on 14 October, in Birmingham and reported back in detail in the Newsletter; which remains the primary source current information for patients. underpinned by much 'base information' on the Behcet's Web Site. Professor Moots reminded the group of one of the successes of Behçet's Patient the Centres. development of the BD Drug Pathway, which forms an essential guide for doctors and clinicians. The topic of How to define a BD Flare consistently, was identified as a core issue that required attention – and this has yet to be achieved.

The first Belfast Behçet's Conference

This was held on 8 October, attended by 57 doctors, patients, families and friends. The Rt Hon Margaret Richie MP opened the meeting and emphasised the need for a 'joined up service for people with BD'. A number of presentations were offered from representatives from the Liverpool and Birmingham Centres of Excellence, to include the origins of BD, a Patient's Journey, the role of Support Coordinators, supporting patients by an Integrated Community, background to genetic research and a session Mindfulness.

Behçet's Families Weekend – Bendrigg Lodge, Cumbria

A highly successful Family Weekend, was held at the outstanding Bendrigg Trust Lodge, Old Hutton, Kendal on 3/4 June 2017. Forty six people attended who made maximum use of the excellent facilities; which has been set up to provide a wide range of adventure activities, led by highly qualified experienced Tutors, for all ages and abilities. Outstanding indoor facilities complement the beautiful outdoor venues and opportunities for active participation in all weather conditions. As a prospective new trustee, I attended, slightly on the spur of the moment, which offered an ideal opportunity to meet patients, families and friends, together with fellow Behçet's trustees and support staff. Participants ranged in age from 18 months to over 60, with activities including canoeing, zip wire, indoor caving, a low ropes course and a sensory room. In the evening, a get together round a camp fire was most popular. Julie

Collier is congratulated on masterminding this administratively difficult and time-consuming task, and with 'bringing it all together' – which presented a number of lessons for the future which will be addressed by the Board.

BSS Helpline

During the year our Helpline had to cease for lack of suitable personnel to man the facility; which is seen as a core activity in the Society. A four-month trial is now taking place using the Support Coordinators within the Behçet's Patient Centres, to see if this can successfully be used as the model for the future. Future forthcoming Data Protection legislation and duty of care issues, and indeed potential liability considerations, will necessitate a considered approach. It may well be that since the earlier days of the Society, with enhanced Society guidance on the Web Site, introduction of the Behçet's Patient Centres (BPC) and Centres of Excellence, and indeed the NHS Choices Home Page the nature of the requirement has subtly changed. Moreover, the task does rely on securing the right individuals to take on the role, and the Trustees will need to consider carefully if individuals continue to routinely change as a consequence of their own illness, which lies at the nexus of the problem. The Board will review progress after the trial and take appropriate steps as necessary for the future of this important requirement.

Newsletter

Clare Griffith continues to provide outstanding service for this essential function; issued quarterly. It remains fundamental to gathering and publishing information useful to those suffering with BD.

BSS Factsheet

Routinely, our Medial Factsheets are reviewed annually. This is vital to ensure they remain current, but also important, in perceptual terms, to ensure confidence in the information the Society provides is seen as current and up to date. Version numbers are being introduce to ensure version control.

Local Support Groups

Difficulty is still being experienced with increasing the number of LSG throughout the country and the nature of this function will be reviewed in 2017/8.

Fundraising and Membership

Members, family and friends have continued to surprise us with exciting and innovative ways to support the Society. Fantastic fundraising activities have accumulated in the region of £18k to boost our funds this year! A fuller report follows, but we thank everyone for such a brilliant effort. I should like to thank Langland Bay Golf Club for their particularly generosity in raising £8000, in various ways, and nominating us as its Charity of the Year. Membership has maintained its buoyant state, with over 1000 names on our database, and I would urge members to encourage further 'additions to our family' in future years.

Administrator

Julie Collier has continued to provide excellent service as part-time Administrator. Whilst requesting slightly reduced hours, the benefit to the society of this post remains both evident and fundamental; without which administrative support for the society would be solely dependent on volunteers afflicted with Behçet's. We will need to consider whether additional support is needed during 2017/8, to bring this support up to envisaged levels, to help prosecute identified initiatives.

Governance

The withdrawal of two chairs (Alan Booth and Gill Millane) and a couple of trustees (Fionnuala McKinley, Tony Wright) in quick succession during the year has tested the governance structure. The aim will to recruit further trustees, so that proper delineation can be maintained between the Officers (executive functions) and a larger more independent group of Trustees. As the new Chair (and cognisant that I am the first such one not to suffer from Behçet's) I congratulate the trustees for navigating their wav successfully through this reporting period; and particularly Hazel McLachlan for importantly and resolutely 'holding the fort' in the interregnum, and in such fine fashion as Vice Chair.


Heulwen Earl continues to support the Society in a variety of ways. This year she sold Easter eggs in her street and raised £30.

Report of the Trustees for the year ended 31 August 2017

The trustees present their report along with the financial statements of the charity for the year ended 31 August 2017. The financial statements have been prepared in accordance with the accounting policies set out in this report and comply with the charity's trust deed and applicable law.

Constitution and objects

The Behçet's Syndrome Society is constituted under a trust deed dated 11 October 2008 and is a registered charity No 326679.

The object of the charity is to relieve and mitigate the distress of persons suffering from Behçet's Disease by:-

- promoting the study of the cause and treatment of the disease and allied conditions.
- gathering and publishing information useful to sufferers and the general public
- co-operating with the medical, allied professions and other societies with similar aims.
- providing financial assistance to relieve poverty among Behçet's Patients.

Organisation

The trustees who have served during the year and since the year-end are set out on page 13. Trustees are elected at any time during the year and the trustees are presented to the members at the Annual General Meeting.

The trustees act as a management committee and meet quarterly to administer the business of the society. All trustees are unpaid volunteers working on behalf of the Society in their own time.

Trustees' responsibilities in relation to the financial statements

Law applicable to charities in England and Wales requires the trustees to prepare financial statements for each financial year which give a true and fair view of the charity's financial activities during the year and of its financial position at the end of the year. In preparing those financial statements, the trustees are required to: -

- select suitable accounting policies and then apply them consistently;
- make judgements and estimates that are reasonable and prudent;
- state whether applicable accounting standards and statements of recommended practice have been followed subject to any departures disclosed and explained in the financial statements; and
- prepare the financial statements on a 'going concern' basis unless it is inappropriate to presume that the charity will continue in business

The trustees are responsible for keeping accounting records which disclose with reasonable accuracy at any time the financial position of the charity and enable them to ensure that the financial statements comply with the Charities Act 1993. They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

Reserves

The trustees aim to maintain reserves at a level that lies approximately between the total income that the Society would expect in a six month period and that in a full financial year: currently the reserves are slightly higher than that so the Board will be looking into additional projects and services that can be undertaken for members in the year ahead.

Risks and public benefits

The trustees do not consider that the Society faces any significant risks in the near future, but they are mindful that the level of subscriptions and donations has tended to drop recently as more members have become eligible for free membership from being in receipt of UK state benefits and will continue to monitor the situation closely.

The Trustees confirm that they have complied with the duty in section 17(5) of the Charities Act 2011 to have due regard to the guidance published by the Charity Commission.

Report on Financial Statement 2016/17

Another good year for the Society

The Society's finances continue to be in a strong position, which is enabling the Trustees to consider expanding our work in a number of ways.

The annual membership subscription has not been raised for over five years and remains at £20, with exemption for those in receipt of UK state benefits, who form an increasing proportion of our members, with the result that our total income from subscriptions has been gradually decreasing.

We continue to rely for income almost entirely on the subscriptions and generous donations of our members, some of whom have worked hard during the year to raise funds through a wide variety of events. We are particularly grateful to the Langland Bay Golf Club, near Swansea, for making the Society its 'Charity of the Year' in 2016 and raising over £8000 to support our work.

There have been two significant grants from other bodies during the year: a sum of over £8000 from NI Awards for All supported a conference in Northern Ireland and a grant of £3000 was received from the British Association of Dermatologists.

The continuing strong financial position of the Society has enabled the Trustees to run two Family Weekends without charge to members attending and to agree to fund a research project at the University of Liverpool into the incidence of Behçet's in children. It is also hoped to fund another project during the forthcoming year.

The General Fund received income of £63.5k, including £9.1k of subscriptions, £24.8k of donations and activities and sales of £11.9k. The expenditure from this fund was £54.7k. In addition the sum of £14k was transferred to the Restricted Fund to finance the University of Liverpool grant, after which there was a net deficit on the General Fund of £5.1k, giving accumulated reserves of £76.3k.

The Restricted Fund had a total income of £1.3k from donations and £14k from the above transfer. The Grant to the University of

Liverpool is shown in the accounts under 'Creditors' as it represents a commitment against the fund. The accumulated reserve on this fund now stands at £13.8k.

Membership

The Society's membership has remained stable. On 1 September 2017, we had 931 full members, compared with 945 on the corresponding date last year. In addition there were 8 junior members and 54 associate members (most of whom are medical professionals).

The total number of names on our database was 1095 on that date, compared with 1050 the previous year, of whom 893 are Behçet's patients. However these figures include a few members whose subscriptions were more than a year in arrears, from whom we hope to receive subscriptions very soon to avoid having to remove their names from our mailing list at our forthcoming annual review.

The number of members in receipt of UK state benefits, including retirement pensions was 689, compared with 617 the previous year. These are entitled to free membership but many make donations when they can, for which we are very grateful.

Subscriptions may be paid by direct debit, by one-off card through the web site or cheque payment through our office.

Over 300 members make a substantial addition to the Society's finances by Gift Aiding their subscriptions and we would very much encourage all those who pay UK Income Tax or Capital Gains Tax to consider doing so, by means of the declaration on the annual membership renewal form.

Summary

Both the Society's financial and membership figures are in very good shape and the Trustees are optimistic that the Society will continue to go from strength to strength.

1. Basis of accounting

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with FRS102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy note(s).

2. Income

All income is included in the financial statements without netting off expenditure. Donations and fundraising income are treated as General Fund unless they are specifically designated by the donor for the Research Fund.

3. Resources Expended

Resources expended are recognised in the year to which they relate. Irrecoverable VAT is included in the relevant heading.

4. Funds

The General Fund comprises funds that the trustees are free to use in accordance with the charitable objects.

The Research Fund was opened in 1995 and is specifically intended to provide for financial grants to be given to research projects in the UK concerned with the study of Behçet's Disease.
